#### **Terms and conditions of entry**

2. By electing to participate, you accept these terms and conditions as governing the lucky draw. 3. Five (5) conference passes to the ASCI Supply Chain Sustainability Series 2024 will be awarded in the lucky draw. Should the advertised prize become unavailable as a result of circumstances beyond our control, we are free (at our sole discretion) to substitute a prize equivalent to the prize advertised.
4. Entry is free. Entry is open between 9am on 26 Feb 2024 (AEST) and 11:59pm on 15 April 2024 (AEST). Entries received after the closing date will not be accepted.
5. To enter the lucky draw, you must: (a) complete the survey questionnaire; and (b) provide a valid phone number or email address.

7. Following the closing date, the lucky draw winners will be selected randomly from valid entries received. Each entry can only be drawn once.
